# PACIFIC GROVE UNIFIED SCHOOL DISTRICT JOB DESCRIPTION

## CLASS TITLE: Vocal/Instrumental Music Performance Coach

**DEFINITION:** Under the direction of the Principal or designee, provides leadership, supervision, and organization to extra-curricular, after-school Music Performances during the year in accordance with District policies and regulations.

#### **RESPONSIBILITIES:**

- Develop the philosophy of the program so that it is consistent with new and traditional music performance expectations of each school, the Principal, the Board of Education, and the Community;
- Plan music performances only with prior approval of the site Principal or designee;
- Adhere to the instructional and performance schedule approved by the District;
- Organize the program in relationship to music performances, practice plans, and facility use;
- Coordinate all aspects of vocal/instrumental music for a particular performance including the training and instruction of student musicians to perform to the highest standards;
- Apply knowledge of skills and techniques to assist student musicians in reaching their fullest potential;
- Maintain appropriate practice and performance schedules and conform to all District policies and procedures for students;
- Reserve facilities and coordinate trip and transportation arrangements as necessary;
- Provide leadership, demonstrate sportsmanship and be a positive role model for student musicians to be enthusiastic and to demonstrate self-confidence;
- Be knowledgeable and competent in the care and prevention of student injuries, music
  performance teaching techniques, appropriate organization of music students, and
  adolescent psychology as it relates to music performance participation;
- Show respect for music students, officials, and others;
- Respect the integrity and judgment of officials;
- Establish the safety and welfare of the music students as the highest priority;
- Ensure that the integrity of the performance is maintained and that basic values and principles are not sacrificed;
- Ensure all music students participate in practice and in performances;
- Provide proper supervision of student musicians during practice, at performances, at contests and on trips;
- Use discretion when providing constructive criticism and reprimanding students;
- Maintain consistency in requiring all music student participants to adhere to the established rules;
- Properly instruct musicians in the safe use of equipment;
- Support and monitor participation eligibility with regards to grades, attendance, and conduct, so that it conforms to school and district standards;
- Establish a systematic method of distributing, collecting and inventorying music equipment and performance supplies;
- Under the direction of the Site Administrator: Plan and manage the budget of the program.
   Follow school budget policies and regulations.
- Ensure that fundraisers receive prior authorization by the Site Principal and/or Board as required;
- Develop and maintain a positive relationship with students, parents, the media, the community, the staff, and the administration;

- Ensure that volunteer assistants are properly identified and registered with the District Human Resources Department prior to working with students;
- Perform other duties as assigned by the Principal/designee.

### **QUALIFICATIONS:**

- Knowledgeable and competent in: 1) injury prevention; 2) emergency procedures; 3) music
  coaching techniques; 4) skills, techniques, and rules of the performance being coached; 5)
  child psychology.
- Knowledge of the general needs and behavior of children;
- Ability to communicate in writing for the purposes of composing the required reports and other correspondence;
- First Aid and CPR Certification prior to employment and/or beginning of relevant performance event;
- Valid California Driver's License.

#### **EDUCATION AND EXPERIENCE:**

- High school graduation or its equivalent,
- Professional and/or College level music experience, training, and/or previous high school music performance experience is required;
- Valid CA Credential in the defined designated subject.

# **PHYSICAL REQUIREMENTS:** of this position are, but not limited to, the following: **Ability to:**

- Stand in one area for extended periods of time;
- Stand and walk for extended periods of time;
- Sit for extended periods of time;
- Ascend and descend steps:
- See for the purpose of reading student work, laws and codes, rules and policies, and other related matter, and observing students;
- Hear and understand speech at normal levels;
- Understand and carry out oral and written directions;
- Communicate so others will clearly understand normal conversation;
- Communicate using the telephone;
- Bend, twist, kneel and/or or stoop;
- Lift and carry 30 lbs.;
- Reach in all directions;
- Think clearly and rationally to solve problems.

### **WORKING CONDITIONS:**

Indoor/outdoor working environment. Strenuous physical effort characterized by frequent running, standing, bending and lifting.
